Chadron State College is located in a sparsely populated, geographically isolated, economically depressed portion of the United States. A majority of the graduates of the CSC program will teach in rural communities within Nebraska, Wyoming, and South Dakota. Therefore, rural education concepts, elements and strategies are infused within the curriculum. Likewise, the students are provided experiences allowing practices within this environment. The assessment results indicate that the students are prepared at a proficient level for working within this geographic environment. The education program has increased hours in the instruction of classroom management.
