Welcome to the December edition of the CSC Leadership Report. I was so pleased to see many of you at the holiday dinner on Dec. 2. Thank you for sharing some holiday cheer with me! Updates from each of the functional areas of the campus are provided below to assist you in staying up to date on all that is happening at CSC.

Strategic Plan Update

The CSC 2030 Strategic Plan task force has met a total of five times (once per month) to review updated drafts of the CSC Strategic Plan. Their work has resulted in the establishment of four priorities for the College. They include:

- Student Access, Experience, and Success
- Academic Excellence and Workforce Readiness
- Organizational Culture and Institutional Vitality
- Regional Leadership and Impact

Each of these priorities is further informed by a number of priority strategies that describe the types of intended outcomes that will move each priority forward. During this month's meeting, the task force reviewed various performance indicators that can be used to measure the progression and success of each priority. A survey will be sent out to all task force members to compile their collective feedback on these performance indicators, which will be used to finalize the plan. A final draft of the plan will be shared with the campus in January.

In addition to the Strategic Plan, the task force has also been revising the CSC Mission, Vision, and Value statements to ensure they align with the CSC 2030 Strategic Plan and continue to inform our collective work.

Enrollment Management

Enrollment for the spring semester is trending in a positive direction. As of Dec. 12, CSC has 66 new graduate students enrolled for the spring semester, which is 49 more than what we had at the same time last year. Overall, we have approximately 110 new students registered for spring and expect to enroll between 60-80 more students prior to the first day of the spring semester.

The Admissions Office has hosted many students this fall. In November, 69 students attended Eagle Experience Day, which was the largest experience day event we have had in several years. The next Eagle Experience Day is scheduled for Jan. 30. We also have had more than 140 students attend individual visits and 79 student-athletes have made group visits since July 1. We could not create a

quality experience for these prospective students without the support of the faculty and staff across campus. You help make us stand out from other college visits, and we would like to say “THANK YOU!”

We continue to represent CSC at our regional high schools by attending high school basketball games and giving students a chance to win a \$500 scholarship by making a half-court shot. We have been to Hemingford, Crawford, and Banner County and have plans to attend Chadron, Alliance, Scottsbluff, Hay Springs and others after the winter break. Academics

Student Success and Engagement

Academic Advisors are successfully implementing Eagles360 into their work. Seventy-one percent of referrals assigned to the Academic Advising team have been closed for a successful resolution, with a total of 248 cases referred or opened for Fall 2025 (the highest since implementation).

Career Services hosted its Fall Career Fair Oct. 29. Twenty-four organizations recruiting students attended, and 70 students participated. Career Services will host a Spring Career Fair March 18 from 1 to 5 p.m. in the Student Center.

Community Engagement

The annual Family Math night was Oct. 23 at the Chadron Intermediate School. Third and fourth graders enjoyed testing their math skills at this event which was sponsored by Assistant Professor Jordan Haas, Math GA Aubree Quast, and several Math Education students.

The annual Creepy COIL Crawl was Oct. 31. More than 350 Pre-K to fourth graders explored the Sciences during this event. This event was hosted by the Physical Science faculty and staff, Business Department colleagues, the Health Professions Club, Chemistry Club, CSC Volleyball, and Physical Science Education students.

Faculty Research & Scholarship

Dr. Mathew Brust has finished inventorying the grasshopper and lady beetle collections. The grasshopper collection contains more than 12,800 specimens of more than 100 species. The collection includes grasshoppers that are mostly from Nebraska, but also a bit of material from areas such as Wyoming, Colorado, South Dakota, Kansas, Oklahoma, and Wisconsin. Numerous county records and even some state record vouchers are contained in the CSC collection. The lady beetle collection contains more than 2,600 specimens, mostly from Nebraska but also nearby states. As many native lady beetles have vanished from the eastern U.S. a great amount of material in the collection is considered rare.

Athletics

Chadron State Athletics is beginning its winter sport season after a successful fall season that saw coaches and student-athletes honored on the field and in the classroom.

Chadron State football won eight games, finished second in the Rocky Mountain Athletic Conference standings, and qualified for the NCAA playoffs. Head Coach Jay Long, in his 14th season, earned the RMAC Coach of the Year award and the AFCA Regional Coach of the Year award for the first time in his career.

The Eagles had seven First-Team All-Conference selections, including RMAC Defensive Player of the Year Logan O'Brien and Special Teams Player of the Year Brodie Eisenbraun. Both O'Brien and Eisenbraun were also among CSC's four First Team All-Academic selections, with O'Brien winning that honor for the third year in a row.

Chadron State's winter sports have been facing the best of the best. The Eagle women's basketball program competed against a pair of Division I opponents in Wyoming and Northern Colorado while men's basketball has faced West Texas A&M and Minnesota State, who were two of the final four teams nationally in 2023-24.

Men's wrestling recently went toe-to-toe with Nebraska-Kearney, the No. 1 team in the nation and defending national champions, and won four of 10 matches. Keegan Gehlhausen remains the No. 1-ranked wrestler in the nation at 184 pounds. The men's and women's wrestling teams have a combined four nationally-ranked wrestlers.

Administration and Finance

Accounting and Business Office

Jasmine Parsons has accepted the Athletic Business Manager position and starts in that role Monday, Dec. 15. The Business Office will miss seeing her but wishes her well.

The annual revenue bond audit was completed, and the report was approved by the Board of Trustees during its November meeting. The annual basic financial statement audit is complete, and the

report will be presented to the Board at its January meeting. The annual federal audit is in its final stages and is expected to be completed by the end of January.

Budget

As of Nov. 30, tuition revenues were 48.2% of the tuition budget, and expenses were at 44.17% of the budget. Tuition remissions were at 27.13% of our tuition revenue. The enrollment decline of approximately 9% has had a significant impact on our financial planning, and as a result this will be a particularly challenging year.

Given these constraints all departments need to prioritize spending strictly on essential activities. Every decision must be made with fiscal responsibility in mind.

As part of the efforts to respond effectively to this enrollment decline, Academic Affairs has been working diligently to align course offerings with current student demand. The goal is to ensure that students remain on track for graduation while we adapt to these new realities. This work is ongoing, and adjustments will continue as we monitor enrollment trends and student needs.

We recognize that the months ahead may involve some conversations and decisions. We appreciate your continued commitment, flexibility, and collaboration as we navigate this together.

Contract process

As we approach the spring semester, it is important to note this period represents the highest volume of contract activity for CSC. Early preparation and submission of contract materials will help ensure timely review and processing.

With the fall semester ending, we'd like to extend our appreciation for the cooperation and responsiveness throughout the term. Currently, unless there is a significant influx of contract submissions prior to the upcoming break, we anticipate minimal carryover of contracts into the break period. This will allow a more efficient transition into the spring contract cycle.

Human Resources

Nebraska's minimum wage increases to \$15 per hour effective Jan. 1, 2026. Supervisors do not need to take any action for current employees making less than that amount, this is something Human Resources manages.

The [CSC Holiday Calendar](#) is posted on the HR web page under policies and information. This calendar has all the official scheduled holidays through July 2026. A new calendar is typically disbursed in March. The Firefly calendar is shared software and does not reflect CSC's Holiday Calendar.

Math Science COIL

The electrical work needed and referenced in the last Leadership Report will be completed Tuesday, Dec. 16. Once the electrical work is complete the drainage work around the south side of the

building can be finished. The weather and contractor availability will determine whether the drainage work can be completed before spring.

Coronavirus State and Local Fiscal Recovery Funds (CSLFRF) water main replacement

The second phase of this project was substantially completed in September. There are still some small punch list items needing to be completed before the project is 100% complete. These items will be completed as quickly as possible depending on weather and contractor availability. This project is funded by federal funds passed through the State of Nebraska to CSC.

Old Admin elevator repairs

The elevator is waiting for the Fire Marshal inspection scheduled for Wednesday, Dec. 17. Once the Fire Marshal completes the inspection and CSC receives the certificate, the elevator will be back into service. Thank you all for your patience with this project. This project is funded by the 309 Task Force for Building Renewal.

West Court and Brooks Hall asbestos abatement

Asbestos abatement is complete at West Court. We are working with the Nebraska State Patrol to utilize this facility for SWAT training this spring. We are working to secure bids on the demolition and will attempt to demolish this facility once the SWAT training is complete. The Nebraska State Patrol will coordinate with Criminal Justice faculty to allow students to observe parts of the training. This demolition is funded through facility fees.

For Brooks Hall, the College has contracted with a vendor for abatement specification design and abatement monitoring. We hope to bid out the asbestos abatement project early January 2026 with the abatement to follow soon after an award and contract is negotiated. We will determine if the demolition should be completed this spring/summer or wait until the winter months when construction crews are not as busy. This project is funded through contingency maintenance funds.

Sparks Hall

This project is substantially complete and the contractor has a few punch list items to complete. Depending on the weather these items should be completed by the end of January. This project is funded by the 309 Task Force for Building Renewal.

Deaeration tank replacement in the Sheaman Heating Plant

TSP finalized the design for the tank replacement however with the boiler replacement project requiring alternate options we've paused this project to ensure the alternate boiler(s) don't need a different deaeration tank design. We are hopeful with the alternate the deaeration tank can be moved such that it will not require the Heating Plant roof removal and replacement. Once the boiler design is complete, we can start working on the deaeration tank design/specifications and location again. The project is funded by the 309 Task Force for Building Renewal.

The repair to boiler #3 was completed in May, and TSP's design for the boiler #4 replacement is complete. We received the estimated cost for the replacement of boiler #4 and we are working through our options. Due to the cost, we have been working with the design team and 309 on alternate options. We have arrived at a suitable alternative and will work to complete the design. Due to extenuating factors, we will likely move forward with the replacement of one or two wood fired boilers with one or two natural gas fire boilers next fall. The new design will include a large overhead door being installed so we do not have to remove and replace a portion of the Heating Plant roof. Once a project timeline is available, we will communicate it in the next update. The project is funded by the 309 Task Force for Building Renewal.

Backyard project

The Backyard project (formerly known as the Fire Pit project) kicked off with Lee Davies Architecture at the end of April. Lee Davies completed schematic design and has been working on design development and construction documents. We met as a group to review the design development in November. We are hopeful the construction documents can be completed in time to bid the project out this winter, so that the project can be completed in summer 2026. This project was requested by the Student Senate and is being funded with student activity fees.

Utility tunnel repair along Main Street

The utility tunnel running north and south along the west side of Main Street requires repair. There is a degraded section of this tunnel running in front of the Sandoz Center which requires a sidewalk closure. We submitted an emergency funding request with the 309 Task Force for Building Renewal, and we are optimistic they will provide funding for this repair. We have been working with TSP on the design specifications so that the project can be bid out this week, with bids due Jan. 30. Contingent on bids received and contractor availability we are hopeful the project can be completed in summer 2026.

Other Maintenance/Facility Updates

- Rasmussen Mechanical installed the Work Hall and Wing steam hot water heat station this summer but there are some steam reducing and relief valves that still need to be installed. The parts have been received but we need to identify a time to complete the work. The boilers must be shut down for a minimum of two days, so the weather has be cooperative. Once a timeline is established, it will be communicated with campus. As a last resort this work can be completed in May during the annual shutdown.
- Working through elevator challenges in High Rise and the Library. TKE has been on campus several times working on these issues but have not resolved them to date. The parts for the Library elevator were received and repairs were made Friday, Dec. 12, and now the elevator needs another part which will be installed next week. A part is on order for the High Rise elevator and will be installed as soon as it's received.

- The variable frequency drive and pump for High Rise have been ordered. Once those parts are available, they will be installed by a contractor. These parts were ordered in anticipation of need. There is some water pressure fluctuations but everything is functioning.
- The HVAC team has been working through condensate issues on campus. They have identified and resolved most of these issues.
- Burkhiser had a variable frequency drive go bad which was repaired after ensuring the 100 horsepower motor was still functioning properly.
- The steam leak south of the Math Science COIL building has been fixed.
- The Armstrong bleachers were inspected and condemned this summer. The bleachers are being dismantled as time allows by the carpenters, and we will determine whether replacing the bleachers is feasible when considering cost and usage.
- Set and tear down for December commencement is compressed due to basketball games the day before and after commencement.

Title IX Coordinator Update

Following a national search, Jody Motz has been named Chadron State College's Title IX Coordinator. Jody had been the Interim Title IX Coordinator since August. Jody brings valuable experience in case management, domestic violence resources, and abuse prevention programming through her work with the DOVES program. Rebecca Fernau, Assistant Professor of Social Work, will continue in her role as a Title IX Designee.

Stop Campus Hazing Act

The Federal Stop Campus Hazing Act was signed into law in Dec. 2024. As a result, the Nebraska State College System has been working to implement required training, response, and reporting mechanisms. CSC representatives from Student Affairs and Athletics attended a tabletop exercise in Wayne, Nebraska, on Dec. 4, with the workshop centered around a hypothetical hazing scenario.

College Relations

College Relations continued to advance key institutional priorities this semester through coordinated communication efforts, brand implementation, and broad support for marketing initiatives across campus. That work included video and photographic coverage, graphic design, printing, press releases, and social media asset creation, as well as event logistics and coverage. The department also provided strategic content and promotion for major campus events, hosted three successful Graves Lecture Series (more are planned for the spring semester), and continued to grow social media engagement across CSC platforms.

Following a national search, Riley Ellis has been hired as a Publications Specialist in College Relations. Ellis, a CSC alum, has worked at WNCC since 2021 as a Marketing Specialist II and Graphic Artist. His first day is Jan. 5, 2026. Ellis is replacing Dewayne Gimeson, who is retiring after 36 years at Chadron State College. Congratulations, Dewayne!

Information Technology

Thank you to all for completing information security training during Cyber Security Awareness month in October. In addition to information security training completed by all employees, awareness development activities included an online scavenger hunt, tips included in the CSC Connections publication, and on message boards across campus.

The upgrade of CSC computers from Windows 10 to 11 is complete. The Microsoft end of support date of Oct. 14 for Windows 10 has passed. If you have a personal computer running Windows 10, you can upgrade for free provided your computer meets the minimum hardware requirements and you have a compatible Windows 10 version. You can check your PC eligibility from your computer.

IT staff members attended the NSCS IT Summit in November. Summits provide for relationship building with IT colleagues across the campuses, skill development, and information sharing. The November Summit included topics on information security, ADA compliance, and AI envisioning.

Network devices providing wireless and wired connections in the Library and Edna Work Hall and Wing will be replaced the week of Dec. 15. Network connectivity in these buildings will be disrupted periodically during this time. Individuals with offices in those locations received prior notification.
